### **Job Summary:**

This 24-month project, with the potential for extension, aims to advance a just and sustainable energy transition in Bangladesh by promoting renewable energy, advocating for policy changes, and engaging stakeholders. The Project Coordinator will oversee conferences, workshops, and meetings, review energy transition policies and advocate with the relevant stakeholders for any necessary amendments, coordinate capacity building and networking activities, lead campaigns and advocacy efforts, community mobilisation, support community-led research, and organize regional and international conferences, offering a unique opportunity to contribute to the energy transition movement in Bangladesh.
